The A.E.D. went over the report noting the following:

- a. The process of interviewing for the Assistant E.D. is on-going. There have been 42 applicants; six have been interviewed. There are three final candidates from those six. We hope to recommend someone to the Leominster board meeting in March.
- b. David Eisen (Abacus Architects) has been awarded the preliminary design contract for the Green Acres HILAPP. We have 28 units at Green Acres with ice dam problems. We may pull the roof replacement from the HILAPP in order to resolve this issue sooner. We are talking with DHCD at this time.
- c. We have purchased a new copier for the Green Acres office. Service calls, even with the service agreement, are starting to get high.
- d. We are moving ahead with the net metering; Ashby is behind the project.

e. We (the A.E.D. and Anna Phillips) had a good meeting on the personnel policy with board members Mary Giannetti and David Rousseau. We went through the entire policy. We should have something to the full board at the March meeting. The new policy will not completely mirror Leominster's policy.

4. Financial Report:
