Minutes of FHA Regular Board Meeting, August 19 2020 Canton Valley Community Room, Fitchburg, MA

Pursuant to Massachusetts Governor Baker's Executive Order issued on March 12th, 2020 in response to the declared Covid-19 State of Emergency epidemic and per the guidelines set by DHCD's Public Housing Notice 2020-11, and 2020-16, a Regular Meeting of the Fitchburg Housing Authority was called to ordered by Chairperson, Linda Byrne at 10:00 AM on Wednesday, August 19 2020. The FHA Board met remotely and physically in the Canton Valley Community Room in the City of Fitchburg, Massachusetts. The public was invited to listen to the meeting via phone.

Andrew Skoog explained that the Meeting notice was post at the City of Fitchburg, FHA community Room, hallway, offices and also on the FHA Website. Douglas Bushman added that Youth (6 years to 17 years old) Fitness Activity will be held on this Sat for Section 8 participants and Green Acres residents.

9. COVID 19 Updates, Budget, & Event

Douglas Bushman updated that the FHA has resumed the seven day a week disinfecting due to the recent COVID Isolation case at the Durkin apartments. Professional disinfecting has been done twice. He also stated the CARES Act and other COVID Funds total \$75,653.00. On July 29 2020 DHCD has issued Public Housing Notice #2020-17 and authorized Housing Authority to Re-open & Resume Public Housing Inspections, unit construction and work orders. The new system began on Monday August 17th. Also, he updated the Resident Service Coordinators Christy Mylott and Frances Nolivos to combat the social isolation problem during COVID-19. RSC organized a couple events (Cookie & Lemonade event at Daniels Heights co-hosted by the Highlands, Ice-Cream Social event, and Cotton Candy & Popcorn Social Event at Green Acres). David Rousseau had a concern about those who didn't wear masks when they enter the apartments. Executive Director answered the Board of Health is the only one able to make this mandatory. David Rousseau asked the Police Officer to speak to tenants to have people wear a mask or may get fined. Fitchburg Police Dept. Officer Bourne commented that BOH has the authority to order and it is more a supervisory decision for this issue.

10. Motion to Revise FHA By-Laws (Adopted May 17th, 1995 and Revised March 21st, 2012) to Change Dates of the FHA Board Meeting:

The Executive Director explained that this Motion will amend the Bylaw and would change the day of the monthly meeting to the last Thursday of each month with time established at 08:30am. However, the suggested Bylaw change would also confirm the power of the FHA Board to make changes in the monthly meeting schedule as required. The Executive Director noted that the FHA staff could not locate a signed copy of the Bylaws. The Board may want to consider a review of the Bylaws at this time for additional updates from 2012. This motion also authorizes the Executive Director to start to revise the By Laws. Linda Byrne, Chair noted Mary G was ok to move to the last Thursday. He will ask Legal advice from Attorney Dresco or, if he is not able to, he could recommend another attorney who is very familiar with the Open Meeting Law and By-Laws.

14. <u>The New Green Acres</u>: Green Acres is past the beginning stages of its beautification. Fitchburg Police patrol was increased for safety. We had a quiet summer. Children played in Green Acres. Christy Mylott and Frances Nolivos have great resources for a Domestic Violence Packet and great relationship with FPD.

15. Vacancy & HAFIS Report:

Andrew Skoog, Deputy Director, updated the Vacancy Report. As of August 1, the vacancy is decreased from 31 units to 30 units. And the vacant unit days increased from 5,708 to 5,827. However, of the 30 vacancies, 6 are Ready to Occupy (RTO) units, 14 are asbestos off-line units leaving only 10 needing rehab. Douglas Bushman added that Erica Shorts, Director of Elderly Housing, and Genesis Ruiz, Director of Family Housing, have been trained in HAFIS reporting. It is expected that by January 2021 they will fully be responsible for HAFIS reporting for vacancies. Also, The Board discussed other vacancy issues, Wallace Towers Asbestos Offline Units, and the relocation procedure.

The tenants of Green Acres formed a preliminary tenant association in the beginning of 2020, now they are in the process of holding formal elections. FHA staff will assist them in this process.

After a review of the operation of the FHA Congregate Housing Program an agreement has been made with Montachusett Home Care Corporation for them to discontinue such services as of September 1, 2020. We had a great meeting with SUMMIT about managing the Congregate Housing.
