Minutes of FHA Regular Board Meeting, February 26, 2021 C. J. Durkin Community Room, Fitchburg, MA

Pursuant to Massachusetts Governor Baker's Executive Order issued on March 12th, 2020 in response to the declared Covid-19 State of Emergency epidemic and per the guidelines set by DHCD's Public Housing Notice 2020-11, and 2020-16, a Regular Meeting of the Fitchburg Housing Authority was called to ordered by Chairperson, Linda Byrne at 9:00 AM on Friday, February 26, 2021. The FHA's fee Accountant Sue Honeycutt from Fenton & Ewald spoke about the Budget-insurance cost, benefit/retirement went up.

"Teamwork, Excellence and Ability for Your Home and Family"

Douglas Bushman, Executive Director explained other factors as follows:

- Two part-time positions will be removed and two full time positions will be filled one for Elderly & one for Family.
- A MOD Coordinator position will be removed and a Director of Facilities position will be added.
- Reduction in Expenses for Contractors and Materials by \$100,000 from FY2020
- DHCD has rescinded 4% budget reduction and instead will flat-line budget for FY2021.
- DHCD rejected the FHA's request to pause for one year the planned phase out of the maintenance employee budget exemption (\$182,000 FY2020 to \$81,000 FY2021)
- FISH Formula Fund Admin Fee will increase to approximately \$300,000 to \$400,000.
- Continued Reduction in need for outside contractors
- Saving from Collective Bargaining Agreement Modification LOCAL 2034

The Executive Director added other positive factors including the two new federal public housing houses will be available in 2021, and the funds from COVID relief from DHCD. He also added that the AHVP program will provide more vouchers for applicants. Mary Giannetti, Vice Chair asked about write-offs and suggested it should be done quarterly. Andrew Skoog, Deputy Director answered that the Write-offs are scheduled twice a year in the FHA. Sue Honeycutt answered that twice a year is good. The Board discussed about the non-routine expenses.

12. COVID-19 Updates

The Executive Director updated that Covid Team -Christy Mylott, Kim Hergert and Yoko Ishii did a phenomenal job on Vaccine Clinic. Wallace Tower will have 2nd vaccine shot clinic today (February 26) and Durkin will have a clinic in March. And hopefully the FHA will open to the public, inspection and normal work orders will resume in April. 7 days spray is continued.

13. Evictions:

Andrew Skoog, the Deputy Director updated that the cases were decreased, and total is about 17 cases. The RAFT assistance program will be needed to provide to tenants before filing to the court.

14. Vacancy & HAFIS Report (Attachment G)

The Deputy Director updated that the vacancy rate for February 1st, increased from 30 units to 32 and vacant unit days increased from 7477 to 8169. However, of the 32 vacancies, 4 are Ready to Occupy (RTO) units, 15 units are off-line for asbestos, 3 units are off-line for handicapped remodel, leaving only 10 needing rehabs.

16. FHA & Summit-C. J. Durkin Congregate Housing Management

The agreement between the FHA and Summit has been executed and operations should begin in February. The Executive Director thanked Andrew Skoog, Deputy Director, Erica Shorts, Elderly Housing Director and Frances Nolivos, Resident Service Coordinator and Maintenance staff for working on implementation of the agreement.
